

# UN Peace Operations Reform

# And the Secretary-General's Reviews of the UN System

The objectives of this seminar are to discuss and analyze the state of UN Peace Operations reform two years after the release of the report of the High-Level Independent Panel on UN Peace Operations (HIPPO) in June 2015, and in light of review processes launched by Secretary-General António Guterres on the restructuring of the UN's peace and security architecture and on management.

A number of actions have already been taken by Member States and former Secretary-General Ban Ki-Moon following the release of the HIPPO Report, as described in the "Scorecard" produced by IPI at the end of 2017.<sup>1</sup> Notably, the Security Council was briefed by the Secretary-General on 20 November 2015 on his action plan for taking forward the recommendations found in the HIPPO report, and took note of the recommendations of the two reports in a Presidential Statement (PRST).<sup>2</sup> Further, the Special Committee on Peacekeeping Operations "C34" has been driving forward the HIPPO agenda by considering a number of the recommendations in both his 2016 and 2017 sessions.

However, Secretary-General Ban left some of the most important issues raised by the HIPPO to his successor, particularly in the area of finances and restructuring. Secretary-General Guterres has since announced nine priority areas for reforms largely based on HIPPO recommendations, including peace and security architecture reform; efficiency and accountability; prioritized, sequenced and flexible mandates; gender; coordinated system-wide planning, control and leadership; use of modern technology; communication; partnerships with regional and sub-regional organizations and particularly the African Union; and solid and predictable funding to support such partnerships.<sup>3</sup>

During the April 6, 2017 Security Council Thematic Debate entitled "Peacekeeping Operations Review", organized under US presidency, a majority of member states called for the need for implementation of the HIPPO recommendations and commended SG Guterres for taking steps in that direction. Ethiopia also announced its intention of host a high-level open debate, at the level of heads of State, during its Council presidency in September 2017, with a view to facilitating serious discussion on implementing HIPPO recommendations and chart the best way forward.

This seminar will conclude the three-year project "New Issues Observatory" supported by the French Ministry of Defense's Department for International Relations and Strategy (DGRIS) consisting of a series of research and roundtables examining "new" issues in peace operations available papers at http://www.providingforpeacekeeping.org/new-issues-observatory/. It is organized in partnership with the informal "friends of HIPPO" group of permanent representatives co-chaired by Ethiopia, Norway, and the Republic of Korea. This event will be held under the Chatham House Rule of non-attribution, and will bring together representatives of member states, of the UN Secretariat, and experts.
